

Leadership Team Minutes - November 30, 2017

Present: Paul & Cheryl Thomas, Lori Linn, Terri Woods, Heather Grady, Sharon McKay, Marv & Sara Loustenhizer, Bob & Marty Kaylor, Jan Ward, Evelyn Bickel, Marilyn Drudge, and Carolyn Egolf.

Search Committee: Heather presented the compensation package for the Thomases as negotiated with input from District, Search Committee, and the Thomases.

Marv noted that Housing Allowance will come from Parsonage Fund. Of the \$750/month parsonage rent, \$300/month will go to Housing Allowance, \$250 to General Fund, and the remaining \$200 for repairs. Total compensation package =\$61,189.24 for one position being filled by 2 persons. Budgeted amount is adequate.

Thanks was expressed to Search Committee. Jan Ward moved, and Sara seconded the acceptance of the compensation package. Motion passed, and package will be brought to Congregational Meeting Sunday, Dec. 3.

Pastors' Reports: Cheryl reviewed their activities for November, including the shipment of coats to Chebok, materials collected and delivered for Syria, visits, training events, choir/handbells, work with ministry teams, and continuing work with A-V equipment

Paul explained the opportunity for Lincolnshire to serve as host site for events sponsored by **Center for Congregations**. Copies of the set-up agreement were distributed, defining what we need to provide. Marv moved, and Sara seconded we accept the opportunity and compensate Tom Tiernon for any extra time/effort required. Details later.

Appreciation was expressed by Thomases for the willingness and spirit of the congregation and by us to Paul & Cheryl for their leadership, enthusiasm, and encouragement.

Medical Information Update: It was suggested when church directory information is updated, medical information should be also. Original medical info cards were completed in 2015.

Church Sign: Marv has a bid to change information on church sign (service times & Pastors' names.) Bid needs to be rechecked. Service times are to be evaluated in May.

Property Management—Marv Loutsenhizer:

- 2. Furnace motor in parsonage was replaced.
- 3. Water heater in parsonage was replaced.
- 4. Two trees and stumps have been removed.
- 5. Oak trees have been trimmed.
